Upcoming and Recent Projects: Community-led Projects, Research and Course Development

PhD Trial Lecture titled "What can an autonomy of migration (AoM) approach offer to research at the intersection of law and migration studies?" invites a reflective exploration into how researchers the interdisciplinary potential of law and migration studies. Shifting Discourse in Rule of Law Development Policy In collaboration with former PhD colleagues, I'm offering expert input on participatory community engagement for a project focusing on integrating decolonial perspectives into rule of law (ROL) development. The aim is to transition from traditional top-down approaches to more inclusive, community-driven policymaking, thereby connecting decolonial theoretical insights with practical Rule of Law (ROL) applications and supporting people-centered interventions.

Mid-March to May 2024 Academic Writing Lecturer with Erasmus University Leveraging my expertise in academic writing, I'm guiding biomedical students at Erasmus University to refine their writing skills, ensuring they effectively communicate complex research ideas and findings. This role underscores my commitment to enhance students' academic proficiency and facilitate their success in the biomedical field. Courses start from Mid-March for two half days per week.
