Collaborating with four forced migrant communities (Syrian, Afghan, Rohingya, And Somali), leveraging the insights of nine co-researchers from a diverse array of platforms: community-based organizations, digital outlets, and a pioneering blockchain company, all led by forced migrants. Utilizing a transdisciplinary approach, the research aimed to investigate borderscapes, law, and vernacularisation of rights, specifically their roles as instruments of counter-hegemonic resistance.

- spearheaded the 2021 displaced voices special issue: "in their own voices," a collaborative project with refugee community-based organizations and the UEL'S LIVING refugee archive.
- engaged in 2021 SGBV activism for Somali women, amplifying research narratives and women's voices in collaboration with the Somali Women's Association Malaysia.
- coordinated five academic networking events on refugee issues in partnership with the law school and sociolinguistics networks cost action new speakers.
- participated in extensive research training from 2015 to 2019 at Tilburg University, University of Oslo, Duesto University, and Tartu University.
